Also, present were Police Chief Donna Turner, Fire Chief Richard Griggs, Public Works Director David Gray, Human Resource Director Cody Bumpus, Alderman Danny Wallace, Park and Recreation Director Molly Glass, Building Official Lessie Fisher, Assistant to the Mayor Jason Fleming, and Recorder-Treasurer Tina Dunn.

Meeting was called to order by Chairman Alderman Chris Richardson.

Fire Chief Griggs reported the volunteer firefighter orientation was a success with eight interested applicants that will move to the next phase to include a physical abilities test. There were ten hours worked by the volunteers in June. The run report was presented showing 188 calls for the period June 20th – July 18th. The county coverage area collections are \$78,075.00 for the current year. The Musical Festival Safety Plan was presented for review. The fire inspection report was presented for review. The plan of service for the Cotton Top/Hwy 179 was presented for review. Chief Griggs presented proposed fire protection fees. No building permit for new residential or commercial structure within the City of Covington municipal limits shall be issued unless this proposed fire fee has been paid. This proposal will be reviewed and presented at the Finance & Administration Committee Meeting. There are two open positions in the department. The Certification of Appreciation was presented acknowledging the Covington Fire Department has demonstrated a commitment and dedication to firefighter training and safety at the Tennessee Fire Service and Codes Enforcement Activity.

Motion was made by Vice-Mayor Morris and seconded by Alderman Edwards to approve the fire department report.
Motion passed.

Chief Turner reported the department has six vacancies. Training and Monthly Activities were presented for review (See Attached). The department has applied for a COPS Grant which includes two officers and a school resource officer. This SRO will be located at Tipton Christian Academy. The statistics for the month were presented showing 1,388 calls for the month and 109 traffic stops. The Drug Recognition Expert – D.R.E. Policy was presented for review. This policy shall establish the position of a drug recognition expert and will set forth guidelines to aid in the effective recognition, apprehension, and prosecution of persons who are driving under the influence of any drug or combination of drugs or the combination influence of alcohol and drugs. There will be a virtual demonstration this week for a parking safety stick that will help with parking violators. A new application has been submitted for \$100,00.00 to be used in the Frazier Park area. On the July 4th holiday, there were seventeen citations and nine arrests. There is a reward for any information on the arson that occurred at 711 Best Street.

ORDINANCE 1780

AN ORDINANCE TO AMEND THE COVINGTON MUNICIPAL ZONING MAP TO REZONE PROPERTY AT 800 TENNESSEE AVENUE (BASKIN REALTY, LLC PROPERTY) FROM M-1 (INDUSTRIAL PARK) DISTRICT AND R-2 (MEDIUM DENSITY RESIDENTIAL) DISTRICT TO B-2 (HIGHWAY ORIENTED BUSINESS) DISTRICT.

WHEREAS, pursuant to Tennessee Code Annotated Sections 13-7-201 and 13-7-202 a zoning ordinance and map have been adopted for the City of Covington; and,

WHEREAS, the Covington Municipal-Regional Planning Commission has recommended that the following property be reclassified from its current zoning designation to the proposed zoning designation and,

WHEREAS, a public hearing was held before Covington Board of Mayor and Aldermen pursuant to section 13-7-203, Tennessee Code Annotated, the time and place of which was published with fifteen days advance notice; and,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF COVINGTON:

SECTION 1. That the following described property be rezoned from M-1 (City/Industrial Park) District and R-2 (City/Medium Density Residential) District to B-2 (City/Highway Oriented Business) District:
